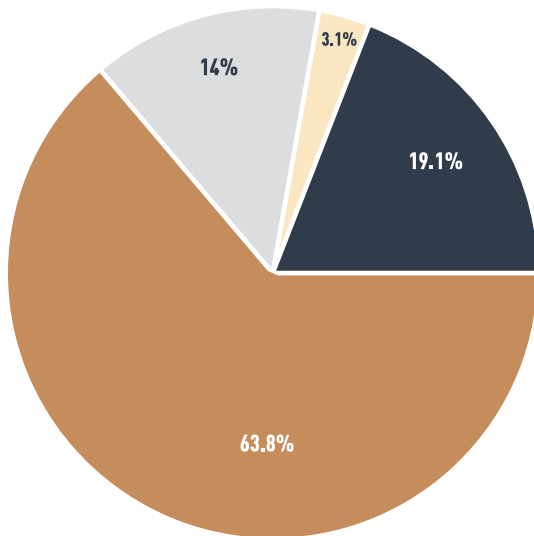

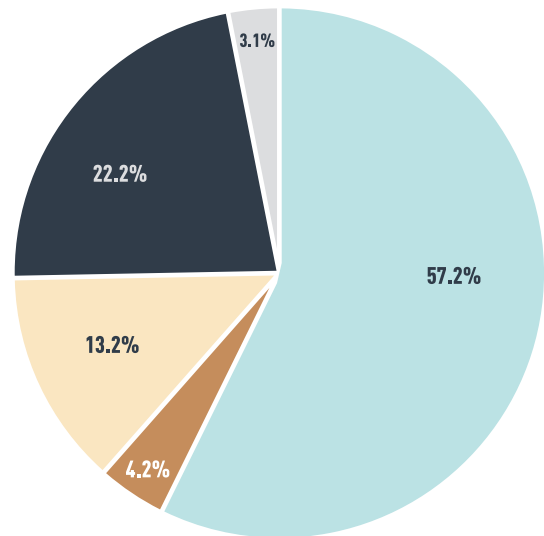

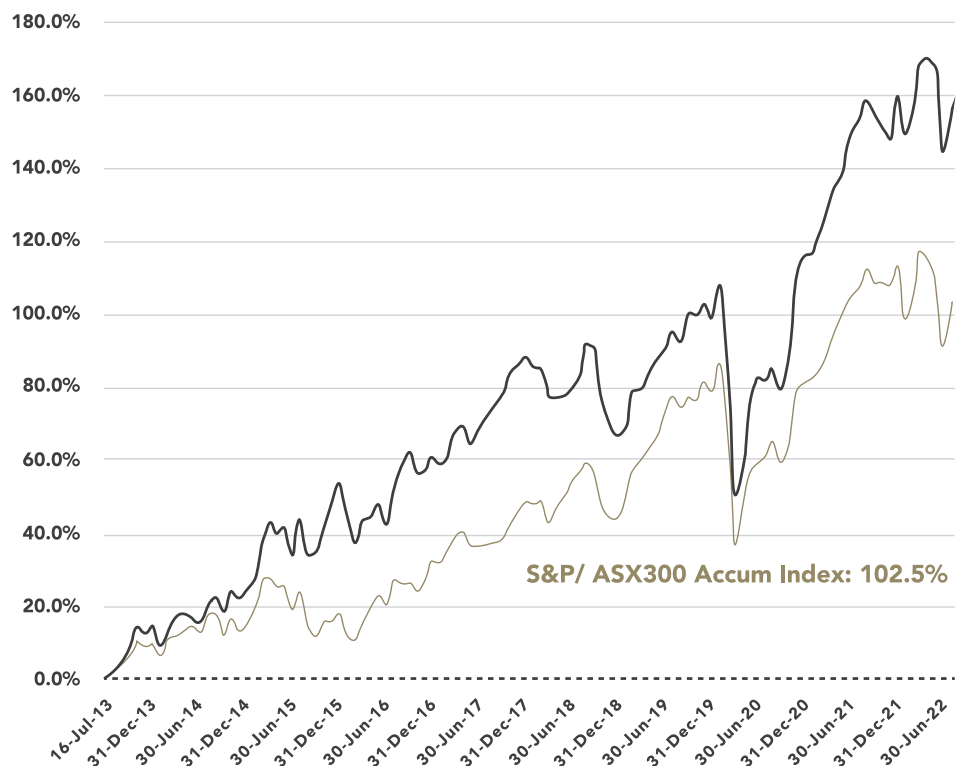
WHY INVEST IN TYCOON GLOBAL GROWTH EQUITY FUND

Equity investing has great power in wealth creation. If you invested \$100 in the S&P 500, which includes 500 of the largest U.S. publicly traded companies, at the beginning of 2000, you would have about \$407.32 at the end of 2022. This is a return on investment of 307.32%, considering we had GFC and Covid-19. The Tycoon Platinum Fund is a long only equity fund, primarily focusing on Australian and US equities share market. The Fund typically invests in companies listed in ASX, Dow Jones and Nasdaq, with some exposure to HK, Singapore and Japanese Stock Exchanges. Historically since 2013 to July 2022, the investment manager of Tycoon Platinum Fund has delivered an average return of 17.3% p.a.
